

DATABASE BUILDING ASSIGNMENT (Deathrow inmates)

Assignment due date: By start of class on Nov. 26.

Use the attached document on Texas death row inmates to create a database in ACCESS.


Your database must contain the following columns:

1. Inmate's name
2. Inmate's age when received (field should be two characters)
3. Weight (field should be three characters)
4. Date of offense (set this field so that the calendar pops up)
5. Native state (field should be two characters)
6. TDCJ# (field should be six characters) (this should also be a required field)
7. Bank balance (set this field to limit the inmate's bank balance to not exceed \$300. Also, create an error message to pop up if an amount over \$300 is entered).

***Make sure to include all inmates in your database.

IMPORTANT: Once you are finished with your database, **e-mail it to Tawnell@yahoo.com**. Because TCU commonly blocks ACCESS attachments, do not send it to my TCU email address. In the subject line, put: DATABASE BUILDING ASSIGNMENT (and your last name).

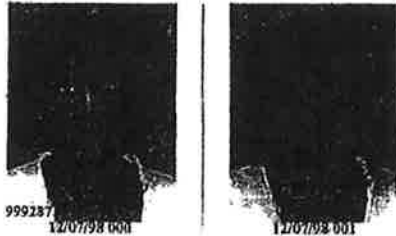
